#### **VISA SUPPORT AND ARRIVAL TO KAZAKHSTAN**

All coming to Kazakhstan are required a Visa.

Please pay attention and fill in carefully the attached excel file (Visa Support to KAZ) and send it to us not later July 20, 2021 \*\*

Information then will be sent to our Government Authorities to organise the necessary Visa Support and confirmation to entry Kazakhstan.

Confirmed document will be sent to each team to apply for Visa in the Embassy of Kazakhstan in their country.

All are required to provide negative PCR tests (72 hours) upon arrival.

Please also send us scan passports of all team members.

#### **TRANSPORTATION**

Nursultan Nazarbayev International airport is 240 km away from Burabai Ski Jumping Hills, which is about 3 hours drive.

Airport pick-ups will be provided to all participants by request. We kindly ask to specify date and time of your arrival.





#### **ACCOMMODATION**

Full board accommodation for the athletes and officials will be provided according to FIS Quotas, beginning one night before the first official training to a night after the last competition.

Price for full board accommodation for over quota athletes/officials and extra single rooms is 80 CHF.

Hotel is located on the territory of Ski Jumping Hills.

#### **INSURANCE**

All competitors must have their own medical insurance.

The Organizing Committee declines all liability for any accident or equipment damaged, second and third party claims during trainings and competitions.

#### **DOPING CONTROL**

According to FIS Standards and Rules.

#### **FIS LICENCE**

To be eligible for participation all the athletes must have a valid FIS Code.
